This summary captures the main discussion points and decisions made at the 27 September 2022 Hackney Board meeting.

The Board approved the minutes of the last meeting and reviewed the actions. It was noted that the Executive would come to a decision on how to manage green risks on the risk register.

Key updates against the business plan included:

- That the staff survey would be rolled out by the end of the month.
- Training sessions for the GCP2 toolkit had been launched.
- The Hackney Early Help Strategic Group met earlier in the month to devise an early help strategy.

Under partner updates, it was noted that:

- There was a shortfall of school nurses nationally and mitigation would require government support.
- Hackney received an Ofsted visit which went well, although known issues around supervision and case recording were identified. This was largely due to high staff turnover for social workers.
- Cabinet had approved the council's Poverty Strategy which was cognisant of the cost of living crisis for children and families.

The Board noted new and ongoing case reviews and their action plans.

The Board received an update on the MASH (multi-agency safeguarding hub).



The following areas were identified as working well:

- The Early Help Hub is exceeding timescale targets.
- Recent audit activity shows that anonymous referrals are taken more seriously further to Star Hobson and Arthur Labinjo-Hughes cases.
- MASH is now able to access reliable data (since June 2022), however there is still a need for more sophisticated data.
- Positive feedback regarding MASH following Ofsted focused visit on 21 and 22 September 2022.

The following areas required strengthening:

- Screening for Children Social Care referrals can improve, 24 / 72 hour targets not consistently met.
- Hackney still undertakes a high level of statutory assessments compared to other local authorities.
- Continue to ensure co-location for agencies to enhance MASH process/ partnership working.
- No MASH Education officer in post, although recruitment is taking place.
- Continued development to strengthen anti-racisit practice via staff training.
- Involve/consider fathers in the screening processes and decision making.
- Council wide phone system issues this has been escalated to the most senior level in the IT department.

The Board thanked the MASH service for the update and presentation.

The ISCC informed the Board that there had been no progress in the Unregistered Educational Settings priority and that it was hoped that the Government's Schools Bill would help strengthen arrangements.

There was a discussion on the proposal to introduce 'young scrutineers'. It was agreed that before launching a new programme, the partnership should utilise existing infrastructure and contacts such as Young Hackney and the Youth Parliament.

There was no other business.

The ISCC thanked colleagues for their attendance and closed the meeting.
