This summary captures the main discussion points and decisions made at the 27 February 2023 Hackney Board meeting.

The minutes of the previous meeting were approved as an accurate record. With regards to the management of green risks, it was noted that the Executive came to the following decision:

'For risks that relate to the core effectiveness of the LSCP (risks 1,2,3,9 and 10) AND the CHSCP's priorities (Risks 4,5,6,7 & 8 (UES), these remain on the register regardless of rating. However, risks relating to specific multi-agency challenges can be removed either by 'professional judgement' or through the 'third cycle rule' as in Option 3 above'.

In discussing the CHSCP Business Plan, it was noted that:

- The Self Assessments and Staff Surveys had since been circulated.
- Negative media coverage had impacted staff morale at the MPS. However, having met the new Borough Commander, the ISCC was optimistic of positive changes in the local context.
- New training was being co-delivered by the local authority and police subsequent to the Child Q Report.
 The training covered what an arrest looks like, what it is like to come into the station charged with a
 crime and generally on how policing works. The training has been incorporated into the wider CHSCP
 training programme for multi-agency reach.
- Discussions were held regarding the approach to parental consent and whether this was required for school nurses to carry out assessments on children already on a child protection plan.

The theme of the written partner update was to provide reassurance on alleviating the cost of living crisis on children and families. Having reviewed the submissions the ISCC was satisfied that there were good efforts being made to safeguard children and families in that context.

The Board received a presentation from Hackney Housing in response to the Awaab Ishak case. The Board was satisfied that Hackney Housing had provided sufficient reassurance on mould management and had implemented an appropriate plan of action.

The Board approved the CHSCP Neglect Strategy.

Following the decision to train professionals on the GCP2 Toolkit, significant concerns were raised with regards to the materials and scorecard. It was felt that the toolkit used a eurocentric approach that was not relatable to the majority of supported families in Hackney. In addition, the scoring was inconsistent with current council safeguarding frameworks and often advised a statutory protection plan be triggered for relatively minor concerns. It was agreed that the Partnership would disengage with GPC2. The Neglect Steering Group would consider next steps.

The Board noted new and ongoing case reviews and their associated action plans.

The Board noted the Partnership Performance Dashboard.



The Board agreed to take part in a pilot for agencies to produce a 'Safeguarding Statement'. The pilot aimed to test how easy the form was to complete and to make any suggestions for improvement.

Under any other business it was decided that the theme for the next partner update would be to find where disproportionality was manifesting itself in the context of each partner agency's service delivery.

The ISCC thanked colleagues for their time and closed the meeting.
