This summary captures the main discussion points and decisions made at the 25 May 2023 City Board meeting.



The minutes of the previous meeting were approved as an accurate record. The Board was informed that the Executive had decided to discontinue the roll out of the GCP2 toolkit in Hackney, due to concerns raised on its suitability by professionals. The City decided to independently trial the toolkit for a further six months and report back before making a final decision.

The Risk Register, Operational Risk Register and Business Plan were noted without significant amendments.

There was a lengthy discussion on a renewed focus for the City Board to distinguish itself from the Hackney Board. It was agreed that this would be taken forward at a separate meeting to plan for improvements.

With regards to staffing at the City of London police, it was noted that a request for five additional officers has been made. The CAID (Child Abuse Image Database) was also fully implemented and more officers were being trained in its use.

The Board discussed new and ongoing Case Reviews and noted them for information.

The Board's sub groups submitted their end of year update reports for information. Other reports that were noted included the Performance Dashboard and the Think Family Draft document. Colleagues were asked to contact RMc if they had any further input into these documents.

It was agreed that the partner update theme for the next meeting would be 'the three most significant blockages to partnership working'.

The ISCC reminded colleagues to read papers attached to the agenda pack for information. These included:

- LADO/ NPCC POLICE data sharing agreement
- LSCP Changes to Threshold Document & Annual Report
- Letter from Tri-Ministerial Partners
- LINK to new online referral form for LADO referral

The ISCC thanked colleagues for their time and closed the meeting.
