This summary captures the main discussion points and decisions made at the 12 October 2023 Hackney Board meeting.

The Board approved the minutes of the previous meeting. The Board was informed that the Executive had decided to publish the minutes of the Board and Executive meetings in a summarised format to maintain confidentiality.

There was a discussion on the safeguarding risks associated with the Israel / Gaza conflict. It was agreed that radicalisation and racism amongst young people should be included on the risk register.

During the Partner Updates item it was noted that the CAMHS Tier 3 service continued to experience challenges regarding wait times. However, a Saturday clinic and a single point of registration was alleviating the pressure somewhat.

The Board expressed interest in receiving a presentation from the police neighbourhood engagement team on community projects being delivered. This was noted for the Forward Planner.

New and ongoing case reviews, the Inspections Framework and the Performance Dashboard were noted for information.

Results from the Staff Survey showed that issues around workforce and capacity remained a challenge for partner agencies - some good indications of management support. This response was similar to previous years.

It was agreed that the adoption of the Pan London SCP Threshold Document would be put on hold because the document required refinement to align more closely with Hackney Framework - such as inclusion of indicators relating to Safer Sleeping.

Under any other business, there was a request to review guidance on fabricated illness further to learning from the Lucy Letby case. The ISCC agreed to take this into consideration.

The Board was reminded of the Right Care Right Person guidance in response to new police policy on mental health related calls.

The ISCC thanked colleagues for their time and closed the meeting.
