#### Nature / Type of Organisation and Services Provided:

The Corporation of the City of London provides a wide range of services to residents, workers and visitors to the City of London. The Department of Community and Children's Services (DCCS), has a wide remit to provide housing, education, social care and community services to the residential and worker population of the City of London.

#### Our commitment to safeguarding children:

The Corporation of the City of London recognises that child protection and welfare considerations must be reflected in all its policies, procedures, practices and activities. Everyone has a responsibility to safeguard the welfare of children, young people and adults at risk, whatever the role of the individual, or the City Corporation service or department they work in. Within the DCCS Outcomes Framework sets out our five priority themes. These are:

Independence, involvement and choice - People of all ages can live independently, play a role in their communities and exercise choice over their services Health and wellbeing - People of all ages enjoy good health and wellbeing

Community - People of all ages feel part of, engaged with and able to shape their community

#### Identified Risk (1)

Huge movement of children through the City, due to attending schools, cultural events, and transport links.

### How are we mitigating this risk? (1)

Staff and volunteers are appraised of how to refer to children to the correct LA Clear processes in place to support the identification of need and referral pathways Awareness raising with members of the public. This is done via a number of online platforms including City of London and CHSCP websites

#### Identified Risk (2)

Staff and volunteers not having the appropriate safeguarding training or checks in place

#### How are we mitigating this risk? (2)

Robust safer recruitment processes are in place across DCCS

Appropriate level of DBS checks are completed and updated

Access to regular safeguarding training via City Learning and CHSCP

Clear code of conduct and behaviour to be in place in within DCCS, which are accessible to staff and regularly reference in supervision, team meetings, or 1:1's

#### Identified Risk (3)

Managers across DCCS are clear on their staff or volunteers responsibilities in relation to safeguarding

# How are we mitigating this risk? (3)

A clear, annual updated Corporate Safeguarding Policy is in place

Safeguarding is a priority within DCCS and is part of the Corporate Risk Register

Managers reinforce safeguarding responsibilities with staff and support attendance at appropriate

Managers are aware of how to refer to the LADO and when this is required

# Identified Risk (4)

Use of commissioned and external services staff and volunteers

#### How are we mitigating this risk? (4)

Commissioning processes are in place around safeguarding expectations

Clear expectations are in place about adherence to Safeguarding Policy and Code of Conduct Regular contract reviews to take place to ensure commissioned services are provided inline with expected procedures

Safeguarding training and checks are completed prior to engagement of services

# Identified Risk (5)

Hidden harm may be impacting children such as online bullying, grooming, or living with substance misuse

#### How are we mitigating this risk? (5)

Workers across DCCS are appropriately trained to spot signs and behaviours which may indicate harm is taking place

Firewall and content filters are in place in spaces where children are using Corporation devices Staff are aware of support services available in relation to mental health, wellbeing and substance misuse
