## Nature / Type of Organisation and Services Provided:

The Community Safety, Enforcement and Business Regulations Service (CSEBR) includes the following teams who come into contact with young people- Integrated Gangs Unit (IGU) and Enforcement Team (ET). The IGU provides support to young people and adults to safeguard them from gang exploitation whilst undertaking interventions to reduce gang violence.

## Our commitment to safeguarding children:

The CSEBR Service is committed to ensuring that Children have their community safety needs listened and responded to. We will take a partnership approach to ensuring that we act collaboratively to support children whilst minimising the potential for duplication of professional effort. We are also committed to ensuring that children and parents are provided with regular updates concerning the work of the Community Safety Partnership in keeping them safe.

### Identified Risk (1)

1) Safeguarding Referrals Come direct to the IGU

### How are we mitigating this risk? (1)

1) All safeguarding referrals that come direct to the IGU are passed immediately to the Hackney MASH and an audit trail of the referral is retained for future reference and scrutiny.

2) Safeguarding access and Support to children from the IGU

### How are we mitigating this risk? (2)

2) All children's interventions undertaken by the IGU will be overseen by the Extra Familial Risk Panel (EFRP) and there coordinated and tracked for improvement. The IGU Will not act in a unilateral way but under the governance of the EFRP

### Identified Risk (3)

3) Children found committing ASB are not referred to Children's and Families.

### How are we mitigating this risk? (3)

3) Should our ET identify a child committing ASB or at risk of ASB they will be referred immediately to the Hackney MASH to ensure that the wider safeguarding interventions are effective and integrated.
