## Our commitment to safeguarding children:

The Homerton is committed to have arrangements in place that:

- Meet the CQC Safeguarding Fundamental Standard which states that: Children and adults using service are protected from abuse and improper treatment.
- Responds to emerging contemporary safeguarding children issues

### Objectives

- A child centred approach for all staff irrespective of whether or not they work in adult or children services.
- Ensure that all children particularly those with additional needs receive early help and early intervention when safeguarding concerns are identified.
- Require all staff to undertake safeguarding children training and participate in supervision commensurate with their role.
- Require staff to 'Think Family' when there are concerns about mental health, physical well-being or drug or alcohol use in parents or carers.
- Support staff to be proactive and contribute to multi-agency safeguarding arrangements.

### How are we mitigating this risk? (1)

The additional vulnerability of this group children is highlighted in safeguarding children training and in the safeguarding children policy.
