We are a fully inclusive, two form school (4-11yrs). We value every child as an individual and respect our multi- cultural community. Our vision for HNPS is to provide students with access to the widest range of opportunities and instilling self-belief, intellectual curiosity and responsibility towards others in society.

Our commitment to safeguarding children:

Hackney New Primary School is committed to providing Early Help, Safeguarding and Child Protection in order to promote the welfare of all its pupils. Governors expect all staff and volunteers to share this commitment.

HNPS and their staff are an important part of the wider safeguarding system for children. Staff are in a position to identify concerns early, provide help for children, promote children's welfare and prevent concerns from escalating. This system is described in the statutory guidance Working Together to Safeguard Children.

We have a main Designated Safeguarding Lead on site or available by phone/email and six trained Deputy DSL's. All Designated Safeguarding Leads have received training in order to undertake the role and support staff to carry out their early help and safeguarding duties and responsibilities.
